

Semaglutide 1mg/mL Sublingual Suspension

Visually Impaired

What is this medication?

Semaglutide is a medication used to help control blood sugar levels in people with type 2 diabetes. It is also used off-label to support weight loss in some patients. This specific formulation is a sublingual suspension, which means it is placed under the tongue and absorbed through the tissues in your mouth.

What are the ingredients?

This is a compound formulation of Semaglutide 1mg/mL.

What should I tell my healthcare provider before I take this medication?

Let your doctor or pharmacist know if you:

- Are pregnant or breastfeeding
- Have a history of pancreatitis or thyroid problems
- Take insulin or other medications for diabetes or weight loss

How should I use this medication?

- Use exactly as your healthcare provider tells you.
- Shake the bottle gently before each use.
- Using the provided dropper or syringe, place the prescribed dose under your tongue.
- Do not swallow the medication right away. Let it sit under your tongue for at least 60–90 seconds to allow absorption.
- Avoid eating, drinking, or rinsing your mouth for at least 5–10 minutes afterward.

What if I miss a dose?

If you miss a dose, take it as soon as you remember, unless it's close to the time of your next scheduled dose. In that case, skip the missed dose and resume your regular dosing schedule. Do not double up on doses. Contact your provider for guidance if you miss more than one dose.

What may interact with this medication?

Semaglutide may slow digestion, which can affect the absorption of other oral medications. Tell your provider if you are taking oral birth control, blood sugar-lowering medications, or thyroid replacement therapy. Avoid alcohol, which may increase the risk of low blood sugar or gastrointestinal side effects. Always inform your healthcare provider before starting or stopping any medications or supplements.

What side effect:

Common side effects may include nausea, vomiting, diarrhea, constipation, or decreased appetite. These usually lessen over time. Serious side effects may include pancreatitis, gallbladder issues, or allergic reactions. Cyanocobalamin is generally well tolerated, though mild redness at the injection site may occur.

This list may not describe all possible side effects. Call your doctor for medical advice about side effects and any unusual problems while taking this medication. If you experience a serious side effect, you or your doctor may send a report to the Food and Drug Administration's (FDA) MedWatch Adverse Event Reporting program, online (www.fda.gov/Safety/MedWatch) or by phone (1-800-332-1088).

What should I watch while using this medication?

Monitor your weight, appetite, blood sugar levels (if diabetic), and any gastrointestinal symptoms. Report significant weight loss or persistent side effects to your healthcare provider. Stay hydrated and maintain a balanced diet as advised by your care team.

Where should I keep my medication?

Store according to the label instructions. Refrigeration is typically required, unless otherwise noted. Do not freeze. Keep away from light and heat. Keep out of reach of children and pets.

Disposal: Do not flush or pour unused medication down the drain. The best option is to use a DEA-authorized drug take-back location, which you can find at rxdrugdropbox.org. If that's not available, mix the medication (still in its vial or drawn into a syringe) with an undesirable substance like used coffee grounds or cat litter, seal it in a plastic bag, and discard it in the household trash—after removing any personal information from the label. Used syringes must be placed in an FDA-cleared sharps container and taken to an appropriate sharps disposal site. If you're unsure, contact your pharmacist at 727-498-1228 for guidance.
